

‘The 2 Day Getaway’ Contest  
Official Rules and Regulations  
(‘Official Contest Rules’)

*These are the official rules and regulations **governing ‘The 2 Day Getaway’ contest!***

1. ‘The 2 Day Getaway’ Contest (the “Contest”), sponsored by Destination Cape Breton Association commences at **12:01am AST on October 1, 2019, and concludes at 11:59 pm AST on October 31, 2019** (the “Contest Entry Period”).
2. How to Enter:
  - a. No purchase necessary.
  - b. Post a Fall themed photo of Cape Breton Island on your **public** social media account. The hashtag **#FallForCapeBreton** must be in each post to be entered into the contest, our accounts must be tagged in your post. This contest is limited to Facebook, Twitter, and Instagram in regards to social media platforms.

All entries (“Entries” or an “Entry”) become the property of the Sponsor and will not be acknowledged or returned.

3. The Contest is open to all residents (excluding areas where prohibited by law) who are 21 years of age or older at the time of entry except the Contest is not open to employees of Destination Cape Breton Association or its affiliates, subsidiaries, advertising or promotional agencies, or immediate family members of such employees (defined as parents, siblings, children, and spouses, regardless of where they live), or anyone who is domiciled with such employees. The Contest is subject to all applicable federal, provincial, and local laws and regulations and is void where prohibited.
4. Entrants who have entered through fraudulent means or who have provided false or misleading information will be disqualified.

- Dining experience for 2 at Woodroad Restaurant, which is a participant of our '2019 Taste of Autumn Campaign.' *\*Woodroad experience will be a set menu of seven seasonal & locally inspired dishes.*
- A helicopter ride for two people, with Breton Air in Sydney, NS.
- Car rental from Budget Car Rental in Sydney, NS. Car rental to be picked up and dropped off at the Budget Car Rental on Welton Street in Sydney, NS.
- All taxes and accommodation levy fees (gratuities not included).

Any additional costs and/or fees incurred by the winner and/or the accompanying traveler are the sole responsibility of the winner and/or accompanying traveler. Meals, beverages and incidentals are not included in the prize package other than what is listed above. Also, the selected winner or accompanying traveler must have a valid driver's license. Insurance for the vehicle is the responsibility of the winner along with any over the counter (OTC) products (i.e., GPS); therefore, a valid credit card is required. The selected winner is also responsible for refilling (gas) the vehicle before returning it.

'The 2 Day Getaway' Prize Package is not convertible to cash, will not be substituted, and must be accepted as awarded. **Unused portions of the prize**

**package is forfeited as of October 31, 2020.**

8. **Five (5) finalists** of the contest will be selected by a panel of DCBA staff from all eligible entries received during the Contest Period. Once selected, these finalists will be entered into the voting portion of the contest on [cbisland.com](http://cbisland.com). The voting portion of the contest will run from **November 1, 2019 to November 11, 2019**. *The winner with the total amount of votes will be determined on **November 12<sup>th</sup>**. The winner will be notified immediately and then announced once they accept the prize by signing the Contest Winner Form.* The odds of winning 'The 2 Day Getaway' Prize Package depends on the total number of eligible entries received for the Contest during the Contest Period.
9. The Sponsor will attempt to contact the winner of 'The 2 Day Getaway' Prize Package via social media private message for approximately two (2) week following the selection process, between 9:00 am Atlantic and 8:00 pm Atlantic. If the Sponsor is unable to make contact with the selected winner after five (5) attempts, the selected winner will be disqualified from the Contest, rendering the selection null and void, and another winner will be chosen from the remaining eligible entries received during the Contest Period. The Sponsor will then attempt to contact the newly selected winner as described above. This procedure will be repeated until contact has been made with a selected winner within the designated time.
10. In order to win 'The 2 Day Getaway' Prize Package, the selected winners must meet all of the following conditions:
  - (a) The winner must provide proof of identification;
  - (b) The winner will be required to sign and return the Contest Winner Form sent to the winner via email that declares they have read the Contest Rules & Regulations and are accepting the prize and all the terms that go with doing so. The signed Form must be returned to the Sponsor at the Destination Cape Breton Association office via email within **7 days** from the date the Form is sent to the winner via email; and
  - (c) The winner must otherwise comply with these Official Contest Rules.

In the event the selected winner fails to satisfy any of the above conditions or cannot accept 'The 2 Day Getaway' Prize Package for any reason whatsoever, then the prize package will be forfeited and will not be awarded to any further entrants.

By participating in the Contest, entrants consent to the Sponsor's collection, use and disclosure of the entrant's personal information provided on the Entry for the administration of the Contest. The entrants also consent to the Sponsor's collection, use and disclosure of the entrant's personal information provided on the Entry in aggregated form, in order to create reports regarding entrant demographics, which reports the Sponsor may, in its sole discretion, use and disclose to others for the purpose of governance and accountability. The Sponsor will not otherwise sell or disclose entrants' personal information.
